GOAL: Become Development Ready

DESIRED OUTCOME: Market-driven defined development strategy supported with tax base financial goals and community prosperity indices, investment strategy, a physical image and a unified community.

STEPS:

- 1. Convene the Planning Commission, Township Board and Downtown Development Authority to discuss and unify around Goal.
- 2. Convene a Development Ready Ad Hoc Committee made up of members of the DDA, PC and TB and other stakeholders to lead the effort.
- 3. With the input of community stakeholders, have a Visual Corridor Appearance Plan prepared that will not only create a visual image of the US31 Corridor but also will show key community assets and incorporate market driven development opportunities into a cohesive "package" that will be able to communicate Filer's Development Readiness.
- Discuss the pros and cons of a DDA as a tool to achieve community economic development goals
 versus a Corridor Improvement Authority. Invite Dan Leonard from the MEDC to lead those
 discussions.
- 5. Aggressively seek out development opportunity as indicated by the recent Market Analysis Study recommendations.
