DDA Director Report

November 2023

Hamlet:

John Boonstra communicated that they would not have anything for the Boards to look at for the November meeting but are eyeing December to present their ideas to the Boards. I was told they have a site plan of their project and are evaluating the pro forma (which informs them on the financial feasibility of the project considering their finances, Township incentives, and local/state financing opportunities).

Jason Balaban's team is working to collaborate with Geerlings Development. They have been exploring facade improvements, new tenant compositions, interior repairs, and forming a working relationship with UHaul, all with the Hamlet project in mind. They have shared their list of properties available for lease; I shared the list with many groups in the region interested in economic development. They are intrigued by the idea of the Veterans Clinic and an assisted living facility. But, they have not ruled out demolishing their existing structures to add to the Hamlet project. They routinely request to be a part of public meetings.

Balaban's team requested that the DDA consider developing a facade grant opportunity. They need \$10,000.00 to do the facade improvements.

Holiday Lighting:

The community found a great community partner in Scott Fisher and Dane Colby, D&S Development, owners of the building at the southeast corner of Merkey and US31. They retooled their redevelopment design ideas for their building to ensure the pine tree was not only saved, but positioned well for use by the community. They will also be creating a wooden structure close to

the tree to be used for any number of uses related to community and the tree. Shine installed the lights but had to use a temporary power outlet (because of the construction work going on to the main building) to light the tree. I am working with D&S Development to find a spot to plug the lights for the duration of the season.
